REGULAR MEETING

1. Call to Order

Chair McNally called the meeting to order at 4:35 p.m.

Public Comment – None

2. Approval of Minutes #323, January 9, 2019

Motion was seconded. Motion was carried.

COMITTEEE DISCUSSION/ACTION

3. Academic Affairs/Workforce/Student Success

Mr. William Thomas made a statement that the committee was incomplete due to Manya Rayner attending via phone. Consequently, all the curricula presented for action needed a second. He requested that the second reading be waived due to the immediacy of the request. He discussed the curricula presented for approval. He invited Dental Professor Misty Mesimer to present the Dental Hygiene Program and Professor Laurie Daigle to present the Physical Therapist Assistant Program expansion proposal. Mr. Thomas moved to that the Board adopt the recommendations from the staff regarding these changes.

Motion carried.

Mr. Thomas invited Dr. Tiffany Ray to comment on enrollment. Dr. Ray started with a celebratory statement that enrollment for Spring was phenomenal with a 5% increase in FTE. She added that enrollment is also up for the Summer with registration commencing on March 1st. Due to COVID-19, all student services will be conducted virtually and online to support students. She was happy to report that the funding approved by the Board for the website has been used to contract a vendor. The selected vendor will be sending a scope of work soon, so that the website and branding initiative can get started. In addition, due to end-of-year ceremonies being cancelled, other arrangements will ensure that students are recognized.

Mr. Thomas invited Dr. Jeanne Wesley to comment about the 5G Program. Dr. Wesley stated that the 5G Program is accelerated with moving all our courses online. We will be the college of the future with 5G. They're experiencing some challenges of bureaucracy but everything is moving forward.

Mr. Thomas encouraged the body to donate to the Gladys P. Todd Academy.

4. Executive/Human Resources

Chair Teri McNally began with the President's year-end review. She mentioned that the committee is creating a streamlined process. She added that by streamlining these processes, it eliminates re-inventing the wheel every year. The committee will take the current survey to mirror it with the Chancellor's goals. The committee has a deadline of April 2nd with an April 30 deadline to send the survey to the Board. The goal is to submit the final review by May 14th. The committee will also reach out to other sources regarding a climate survey. Ms. Ann Tidball then requested permission from the Board to move forward with approving the additional working committee. This committee will assist with gaining the necessary information to complete the President evaluation as Chair McNally proposed. All were in favor.

5. Finance/Facilities

Mr. Baron Braswell invited Dr. John Davis to present the agenda and action items.

Dr. John Davis started with presenting these motions:

Motions #1 and 2

- 1. To accept the local funds financials for January 31.
- 2. To increase in the auxiliary maintenance budget by \$250,0000 to repave the east side of the Fredericksburg Area Campus parking lot.

Mr. Braswell moved each item. Motions were carried.

Dr. Davis mentioned the new construction taking place at the Daniel Technology Center. Additionally, Spotsylvania County and property developers have proposed to build a road through the Fredericksburg Regional Campus to allow access for new residential construction. The main purpose is to connect residents to I-95. The process involves the easement of state land to the county. This proposal is still under deliberation due to some insufficient information. Germanna has reached out to VDOT and the Virginia Community College System for their involvement to ensure accuracy of the information received. The college will inform the Board of any updates. Dr. Davis emphasized that we must ensure safety for students, faculty and staff due to the expected amount of traffic that will be on this road.

INFORMATIONAL ITEMS AND OTHER BUSINESS

6. President's Report, Dr. Janet Gullickson

Dr. Janet Gullickson started by expressing her disappointment in the postponement of the building of the new Locust Grove facility by the Virginia State Legislature. Two VCCS facilities in Virginia were funded and two were not. There was concern among state legislators about the state's bond rating if all four facilities were funded. Dr. Gullickson spoke with the VCCS Office and they believe they may have access to design funds so we could proceed. However, with COVID-19 everything may be uncertain. She invited Dr. Davis to elaborate on the topic. Dr. John Davis added that the project was funded through the design phase which was going to last through Jan 2021 with construction in the March/April 2022 timeframe. However, now with this delay, we can probably expect a construction push back through July 2022. All these dates are dependent on the state budget. Dr. Gullickson continued by saying that Germanna might have to come up with the funds to forward fund some of the design but she's waiting to get a statement from the VCCS Office. She introduced Sgt. Chris Anderson who attended in Chief Craig Branch's absence. She praised to Ms. Nancy Smith who is performing very well temporarily for the Director of Finance role. Ms. Smith mentioned Lauren Henson and that the Finance team have been wonderful to work with during the absence of a direct leader.

In other news – Germanna is hoping to become partners with the Navy Community College. She added that we are positioning ourselves to hopefully be a part of that partnership and the location of the Naval Community College will most likely be at Quantico. The potential number of students may be 40,000 sailors and Marines.

Dr. Gullickson also stated that she anticipates the G3 initiative being a boom for our enrollment. The details are changing daily but once they are finalized, she'll offer a very detailed presentation about it. She praised Dr. Jeanne Wesley and her team for doing a phenomenal job making the necessary curriculum changes so that we can hit the ground running. Dr. Gullickson was very proud that VCCS approached Germanna's Student Services team to assist with the G3 on-boarding process. She gave accolades to Dr. Ray and Dean Pam Frederick for making the process wonderful.

Dr. Gullickson spoke on the COVID-19 update and planning. She stated that Germanna has created a dedicated phone number and email address to answer any questions related to COVID-19. Social distancing demarcations were made on campus with extensive sanitization on Fridays. Germanna has students who were exposed to the virus. Staff self-quarantined because they believe that they demonstrated symptoms. She mentioned that our bottom-line goal is to keep operating and to help the community fight this by not taxing the health care system. She also added that nursing students may help with having health check points. Germanna has also cancelled all its events and rentals. The website has been updated daily with FAQs. Mr. Braswell asked her to expound upon the dual enrolled students and what will happen. The students will still be allowed to attend classes virtually. Ms. McNally asked how all the additional COVID-19 preparations will affect the budget and Dr. Gullickson answered that we can support these initiatives, including additional sanitation crews and curriculum deliveries, for this year. She went on to say that Zoom will also be used heavily during this time to accommodate students and scheduling appointments with students.

Dr. Gullickson then gave accolades to Mr. Simon Gray, recipient of the Susie Miller Community Service Award from the Orange County Chamber of Commerce, for his dedicated acts of service.

There was no report from Chair McNally as she allowed Dr. Gullickson to use her time in her report.

RATIONALE

The VCCS-wide Nursing Concept-Based Curriculum was implemented at GCC in Fall 2017 with the first graduating class completing the program in Spring 2019. The NCLEX pass rate for this cohort was 94.3% which is above both the state and national average for the same time frame. This program was written to be a full-time program, but many students are finishing the degree in a part-time option taking all general education courses before they begin the AAS degree in Nursing. There is a need for an online part-time evening/ weekend option in Nursing education for working adults in our service region. In the spirit of the 5G initiative already in planning at GCC, we propose a year-round continuous 7 semester part-time option for the AAS in Nursing degree with online delivery, using the Canvas 5G template. We would offer lab, clinical and simulation in the evening & weekend time frame.

The program is presented in this proposal with options for students to maintain status for Financial Aid of at least 6 credits, with suggested placement of the General Education requirements. Every effort was made to duplicate the success of the traditional and LPN to RN options with application and graduation in the same time frames. By starting in the fall semester, we take maximum advantage of clinical placement opportunities in the summer semester while not undermining the rotations of lab, clinical and simulation already in place around the community for our other options. This part-time option could also be considered for the LPN to RN Advanced Standing working adult, as it would meet the needs of a part time program for many of those students who need to continue employment for insurance and tuition reimbursement considerations.

2. IMPACT of PROPOSED CHANGE ON (Please describe if there is an impact)

CURRICULUM: VCCS-wide Nursing Concept Based Curriculum approved January 11, 2017 by the Virginia Board of Nursing. A letter of intent to provide a new online delivery for the Part-time Evening Weekend option will be forwarded to the Virginia

Board of Nursing (VBON) for Fall 2020, to Accreditation Commission for Education in Nursing (ACEN) for Substantive Change in Fall 2020 and to SACSCOC in Fall 2020 with necessary follow-up required per agency to complete approval processes. Proposal will be presented to the VCCS Nursing peer review committee (NFAC) in September 2020. Request Rollout in Fall 2021 with student applications received in spring 2021 pending approval.

INSTRUCTIONAL LOAD: Additional workload will be required to staff the lab, clinical and simulation component in the evening and weekend time frame. Present Full-time faculty teaching in the traditional and LPN to RN options will be reviewing the present delivery model to convert to online delivery using Canvas templates developed for the 5G initiative degrees. Full Time faculty may choose to participate in the online option as workload allows. Additional faculty needs will be evaluated. The present clinical ratio of student to faculty will remain 6 to 1, with a planned initial cohort of 12 students beginning in fall 2021.

TRANSFERABILITY: Courses are a part of the common Concept-Based Curriculum. The courses are transferable to schools within the VCCS.

ACCREDITATION IMPACT: Prospectus of substantive change for program addition/change in delivery will be filed in the fall 2020 semester to ACEN, which is within two years of implementation as required. An ACEN focus visit may be warranted and could occur as early as Spring 2022. Substantive change reports will be filed with the Virginia Board of Nursing and with SACSCOC in the fall 2020 semester with necessary follow-up as required.

Course Title: Introduction to Nursing Concepts: NSG 100

Course Description

Introduces concepts of nursing practice and conceptual learning. Focuses on basic nursing concepts with an emphasis on safe nursing practice and the development of the nursing process. Provides supervised learning experiences in college nursing laboratories, clinical/community settings, and/or simulated environments. Lecture 3 hours. Laboratory 3 hours. Total 6 hours per week. 4 Credits

Course Title: Competencies for Nursing Practice: NSG 106

Course Description

Focuses on the application of concepts through clinical skill development. Emphasizes the use of clinical judgment in skill acquisition. Includes principles of safety, evidence-based practice, informatics and math computational skills. Prepares students to demonstrate competency in specific skills and drug dosage calculation including the integration of skills in the care of clients in simulated settings. Provides supervised learning experiences in college nursing laboratories, clinical/community settings, and/or simulated environments.

Lecture 0-1 hour. Laboratory 3-6 hours. Total 4-6 hours per week. 2 Credits

Course Title: Professional Nursing Concepts: NSG 130

Course Description

Introduces the role of the professional nurse and fundamental concepts in professional development. Focuses on professional identity, legal/ethical issues and contemporary trends in professional nursing.

Lecture 1 hour. Total 1 hour per week.

1 Credit

Course Title: Health Promotion and Assessment: NSG 200

Course Description

Introduces assessment and health promotion for the individual and family. Includes assessment of infants, children, adults, geriatric clients and pregnant females. Emphasizes health history and the acquisition of physical assessment skills with underlying concepts of development, communication, and health promotion. Prepares students to demonstrate competency in the assessment of clients across the lifespan. Provides supervised learning experiences in college nursing laboratories, clinical/community settings, and/or simulated environments.

Lecture 2 hours. Laboratory 3 hours. Total hours per week 5 hours. 3 credits

Courses for the Part Time Nursing Curriculum

Course Title: Health Care Participant: NSG 152

Course Description

Focuses on the health and wellness of diverse individuals, families, and the community throughout the lifespan. Covers concepts that focus on client attributes and preferences regarding healthcare. Emphasizes population-focused care. Provides supervised learning experiences in college nursing laboratories, clinical/community settings, and/or cooperating agencies, and/or simulated environments.

Lecture 2 hours. Laboratory 3 hours. Total 5 hours per week. 3 credits

Course Title: Health/Illness Concepts: NSG 170

Course Description

Focuses on the nursing care of individuals and/or families throughout the lifespan with an emphasis on health and illness concepts. Includes concepts of nursing care for the antepartum client and clients with common and predictable illnesses. Provides supervised learning experiences in college nursing laboratories, clinical/community settings, and/or simulated environments.

Lecture 4 hours. Laboratory 6 hours. Total 10 hours per week. 6 credits

Course Title: Health Care Concepts I: NSG 210

Course Description

Focuses on care of clients across the lifespan in multiple settings including concepts related to physiological health alterations and reproduction. Emphasizes the nursing process in the development of clinical judgment for clients with multiple needs. Provides supervised learning experiences in college nursing laboratories, clinical/community settings, and/or simulated environments. Part I of II. Lecture 3 hours. Laboratory 6 hours. Total 9 hours per week.

5 credits

Course Title: Health Care Concepts II: NSG 211

Course Description

Focuses on care of clients across the lifespan in multiple settings including concepts related to psychological and physiological health alterations. Emphasizes the nursing process in the development of clinical judgment for clients with multiple needs. Provides supervised learning experiences in college nursing laboratories, clinical/community settings, and/or simulated environments. Part II of II.

Lecture 3 hours. Laboratory 6 hours. Total 9 hours per week. 5 credits

Courses for the Part Time Nursing Curriculum

Course Title: Advanced Professional Nursing Concepts: NSG 230

Course Description

Develops the role of the professional nurse in the healthcare environment in preparation for practice as a registered nurse. Introduces leadership and management concepts and focuses on the integration of professional behaviors in a variety of healthcare settings. Lecture 2 hours. Total 2 hours per week.

2 credits

Course Title: Complex Health Care Concepts: NSG 252

Course Description

Focuses on nursing care of diverse individuals and families integrating complex health concepts. Emphasizes clinical judgment, patient-centered care and collaboration. Lecture 4 hours. Total 4 hours per week. 4 credits

Course Title: Nursing Capstone: NSG 270

Course Description

Provides students with the opportunity to comprehensively apply and integrate learned concepts from previous nursing courses into a capstone experience. Currently, students who take CHM 241 (Organic Chemistry I) are required to take CHM 245 (Organic Chemistry I Lab) as a co-req. Similarly, students who take CHM 242 (Organic Chemistry II) are required to take CHM 246 (Organic Chemistry II Lab) as a co-req. We propose that the co-req requirement for CHM 241 and CHM 242 be dropped, making it possible for students to take the lecture part of the course only (CHM 241 or CHM 242 only). Since it is necessary to understand the chemical reactions for the lab part of the course, CHM 241 would be a pre-req or co-req for CHM 245. Similarly, CHM 242 would be a pre-req or co-req for CHM 245. Similarly for students in scheduling their classes without changing the academic quality of the curriculum.

Background

- Student Activities at Germanna Community College provide opportunities to promote retention, student engagement, co-curricular engagement, leadership, and wellness
- Participation in student clubs and organizations enable students to develop intellectual, interpersonal, and leadership skills, as well as promote a sense of belonging among students
- Per VCCS Policy, all college-recognized and active student clubs or organizations must have a faculty or staff sponsor (advisor)
- Student Activities must be supported with local funds

Proposal

- Germanna Community College would like to provide a stipend to faculty and staff advisors of student clubs and organizations (\$1000/academic year, \$500 each semester)
- Justification for stipends:
 - Student engagement will be more important than ever in this virtual environment, for retention and completion purposes
 - o Clubs and organizations are the best way to facilitate engagement among students
 - Germanna would like to encourage the development of additional clubs and organizations. For this to be possible, advisors will be required and an incentive would be appropriate

FINANCIAL ANALYSIS

Restricted Funds

Year-to-date, \$6,921,354 has been received/disbursed for Federal Aid (Pell) awards. \$61,667 has been received/disbursed in Federal Work Study. Restricted cash is \$69,600 which represents scholarship funds to be disbursed, the majority of which are held in the Carter-Bennett scholarship. These funds are used as a repository for student scholarships, with any balance representing aid to be disbursed.

Plant Funds

\$381,832 in locality contributions have been received year-to-date. \$17,807 has been received in interest income. Contributions to plant funds are designated for plant/capital spending, either maintenance costs or capital projects.

Unrestricted Funds

- <u>Net Assets</u> Unrestricted Fund Balance/Net Assets increased by \$690,671 during the first ten months of the fiscal year. A summary of each fund follows.
- Local Operating/College Board Fund Local appropriations of \$34,721 were received, composed of \$12,215 from Stafford, and \$22,293 from Spotsylvania County. \$18,617 in expenses were recorded, of which, \$8,667 were for student development and recruitment Programs. \$9,950 in expenditures were for storm water retention pond maintenance at the Culpeper location. The balance in this fund is \$591,457.
- <u>Vending Fund</u> We have received \$228,340 in bookstore commissions, \$9,234 in vending commissions, and \$14,754 in investment income for the year. Expenses of \$4750 were incurred with \$1,947 spent on Aux Plant Maintenance for fire and kitchen hood inspections and cleanings, and \$2,760 on Diversity and Inclusion. The balance in this fund is \$2,499,737, which serves as our "rainy day" fund. \$362,522 has been encumbered by Visionpoint Media Inc. for the newly established College Branding project. The College Branding budget is \$500,000.
- <u>Student Activity Fund</u> \$165,687 has been collected, which is 92% of budgeted fees. Expenses of \$34,537 included \$16,380 for Student Activities and Organizations, \$5,878 for Lecture and Culture, and \$10,198 for Wellness & Recreation. The balance in this fund is \$44,566.
- <u>Parking Auxiliary Fund</u> \$194,008 has been collected, which is 92% of budgeted fees. Expenses of \$10,270 were recorded, primarily utilities. A significant portion of this balance will be required for parking and lighting for the new Locust Grove Facility. The balance in this fund is \$918,333.
- <u>Facilities Auxiliary Fund</u> 173,891 has been collected, which is 92% of budget fees. Expenses of \$5,944 were recorded. Balances have accumulated in this fund to provide for significant repair or maintenance expenses of the parking structure at the Fredericksburg campus. The balance in this fund is \$2,467,116.

Report Scope

This is a financial summary of Germanna Community College's State Unrestricted Funds for the first nine months of Fiscal Year 20. State funds make up about 95% of Germanna's total unrestricted operating budget. Local Funds, composed of multiple small funds, are not included in this report.

1. Environment

The COVID-19 pandemic has changed the world. While Germanna is faced with multiple uncertainties, Germanna's fiscal situation prior to the pandemic was solid and is well positioned to maintain its mission online.

The President has stated that we are planning for substantial cuts in state funding beginning July 1 and continuing into FY22. Governor Ralph Northam is recommending, among other "unallotments," no G3 funding; no bonuses or raises for the next two years; delaying capital projects (this includes the new Dr. Frank and Nancy Turnage Health Sciences Building); and a reduction in student financial aid amount passed in January. Additionally, Virginia has implemented a hiring freeze for classified staff in the face of statewide budget uncertainties.

Germanna anticipates receiving \$1.4M of CARES Act funding, but that may not be enough to offset the impacts of potential budget cuts and enrollment declines. Accordingly, our direction is to slow down non-personnel spending for the remainder of this fiscal year and probably for next as well. Fortunately, there is no indication that would require drastic steps by Germanna in the short term. Prudent planning and operations will ensure Germanna's long term sustainability.

2. Sustainability Summary

2.1 Key Metrics

- Enrollment for FY20 increased by 3,506 credit hours, 2.69% over the prior year
- Personnel costs are expected to end the year \$579K under budget
- Non-Personnel costs are tracking close to budget and, should could come in under budget, providing resources for next year's potential budget reductions

2.2 Cash Balances and Year End Projections

As of May 11, both Personnel and Non-Personnel spending was running under budget. With the state hiring freeze and the President's direction to curtail spending for the rest of the year, it is currently estimated that Germanna will end the year with approximately \$995K after setting aside \$400K in the E&G Reserve Fund and before considering the \$1.4M in CARES Act funding. These projections include the planned prepayment of about \$846K in FY21 expenses.

VCCS has indicated that the usual 2% limit of carryforward cash balances may be adjusted for this year to accommodate the pandemic response. VCCS has also indicated that the reserve limit will be doubled. See Appendix A for more on reserve funds.

3. Enrollment

Enrollment for FY20 is tracking ahead of original projections. While the projections for FY20 were for 130,301 credit hours, Germanna is expected to finish the academic year close to 133,807, an annual growth of 3,506 credit hours or 2.69%. (Note that the VCCS SEB 01D report has not been finalized for Spring 2020.)

Enrollment growth:

- 0.41% increase in Summer 2019 credit hours over prior year
- 1.42% increase in Fall 2019 credit hours over prior year
- 4.79% increase in Spring 2020 credit hours over prior year

The total 3,506 increased credits over the prior year equates to about \$701K in additional revenues:

- Using a baseline of 130,000 credits, each percentage point equates to 1,300 credits.
- At \$155 per credit, each percentage point increase in enrollment has the potential to produce approximately \$200,000 additional tuition revenue.
- Revenue increases are offset by incremental costs required to service the additional credit hours, such as adjunct costs for additional classes.

There was no change in tuition and fees for FY20. In lieu of tuition increases, the state provided additional appropriation in the form of a "tuition moderation fund." This funding primarily covered the agency share of salary and wage increases which were effective July 2019 as follows:

- 3% for full-time and part-time faculty
- 2.75% for full-time classified employees with less than 3 years of service
- 5% for full-time classified employees with more than 3 years of service
- 2.75% for part-time wage employees

The enrollment outlook for Summer 2020 is looking great and remains hopeful for Fall 2020. Various enrollment scenarios will be planned to ensure sustainability throughout FY21.

4. Personnel Budget

4.1 Current Staffing

Through May 11, 2020, 83% of the personnel budget has been spent with 87% of payrolls complete for the year. Projections for the remainder of the year indicate that Germanna will finish under budget.

Adjunct payrolls are trending over budget and over prior year actual spending. Adjunct payrolls are projected to end the year \$411K over budget after having been reduced by \$500K during budget development.

Projections for Admin & Professional Faculty, Classified, and Teaching salaries are projected to be under budget and should be sufficient to cover the Adjunct budget overspend.

There are several open positions which have contributed to the personnel spending variances. Classified positions have been affected by the state hiring freeze, however recruiting for Faculty positions continues to move forward judiciously. The current state hiring freeze will increase uncertainty in most salary projections for the remainder of the year and will introduce further uncertainty in the development of the FY21 budget.

4.2 Proposed Staffing Changes

Prior to the pandemic, Germanna had approved several staffing changes for the coming year. These new positions are being prioritized for recruitment to maintain financial sustainability.

In general, staffing changes are dependent on sustained tuition or enrollment increases. A 1% enrollment increase provides approximately \$200K in revenues to cover increased staffing. Also, the cost of hiring a single full-time Faculty member is typically offset by a reduction in Adjunct spending of approximately \$22K

5. Non-Personnel Budget

Through the end of March 2020, non-personnel budgets are 86% spent or committed with 86% of the year elapsed:

Earlier projections assumed non-personnel spending will come in at \$8M, or \$900K under budget. This spending track is comparable with spending over the past three fiscal years.

Planned spending is not indicated in the table above. But at May 11, \$1.25M remained unspent and unencumbered, providing sufficient resources to address non-discretionary spending, pandemic responses (including growth initiatives), and prioritize discretionary spending in this time of uncertainty.

Budgeted amounts that are discretionary should be considered a resource for the uncertain times ahead. These discretionary amounts could be needed in FY21 if budget reductions or enrollment declines are realized.

6. Summary and Outlook

Navigating the uncertainties of the future will require agility and constant vigilance.

6.1 Cost Structure

Germanna's cost structure is fairly predictable, however there will be expenditures required to sustain an online presence, and there may be decreased expenditures in some areas such as utilities.

- The FY21 personnel budget will be planned at full staffing levels, with the intent to fill all identified open positions under various scenarios. The personnel budget will also incorporate several faculty promotions which take effect in August 2020.
- The FY21 non-personnel budget will be geared to remaining operational in an online format with considerations for a phased return of students to campus. Spending patterns will be different than in the past, and in some cases, spending will be higher.

CARES Act funding may be needed to close the gap for increased non-discretionary spending.

6.2 Revenues

Projecting and budgeting revenues will be the difficult task. Germanna has been warned by VCCS of budget cuts that could materialize in Fall 2020, ranging from 5% to 10%. Forecasting tuition revenues will require multiple scenarios during the FY21 budget development.

The chart in Appendix B displays actual revenues for FY19, projections for FY20, and a projected amount for FY21 budget development. The projected amount for the FY21 budget begins with pre-pandemic estimates for State unrestricted funds, increased by the recently announced Non-Credit Workforce Allocation and adjusted for our projected carryforward. Note the placeholder for the potential budget cut that is expected in the fall.

The Non-General Funds Baseline portion uses tuition projections based on 129,111 credit hours which is the three-year average of credit hours delivered. The FY21 projected revenue budget is about \$600K greater than FY20, before including any CARES Act funding. This will allow Germanna to use CARES Act funding to respond to uncertainties that may arise.

6.3 Scenario Analysis

A decision matrix has been developed for Germanna leadership to analyze various scenarios for the FY21 budget development. This decision matrix starts with the projected revenue and shows the impacts of various changes in State funding levels and tuition scenarios. The decision matrix does not factor the CARES funding so that strategies on the best use of these funds can be considered under various scenarios.

Appendix A: Reserve Funds

For FY20, VCCS did not physically transfer cash for the new E&G reserve fund. Rather, reserve fund amounts are simply "earmarked" in general funds. Therefore, the amount committed todate \$400K reduces available cash. Reserve funds may be spent for designated purposes with Chancellor approval. These are specified in section 4.6 of the VCCS Policy Manual.

As we approach the end of the fiscal year, we are expecting VCCS to adjust the amount allowed to be earmarked for the institutional reserve. Last year, GCC reserved \$400K, based on a limitation of 3% of General Fund Appropriations. VCCS is expected to raise that to 6% for the current fiscal year end.

1. Locust Grove Campus Replacement:

Design/Project Progress:

- Initial Art and Architectural Review Board (AARB) review, 03/06/2020. Design very well-received. Commented that the use of Brick was preferred over metal panel for its historical tradition as well as longevity. The front portico was appreciated for its presence in a higher ed facility. Commented that we need to pay attention to shade trees and they will be in direct consultation with Department of Historic Resources(DHR).
- Phase 1 Archeology Survey was completed at end of 2019. Performed metal detection, shovel test pits, and archival research. No significant resources were found in the project area of the new building. No further archeology work recommended. Report was transmitted to Department of Historic Resources(DHR) for review.
- Floor Plan Design: Worked heavily with GCC staff to fine tune plan and incorporate equipment needs. Kahler Slater design consultant for Allied Health has worked with Dean Lisk & her team to clearly define their needs through a series of meetings.
