Germanna at 50! This year marks 50 years since opening our doors in 1970. In many ways, Germanna is still a young institution with an incredibly vital mission to elevate our communities through quality, accessible, and affordable educational opportunities. Germanna goes forward as a college full of promise! Believe me, we're just getting started creating our future together with you.

I've often reflected on Germanna's tremendous past. Under the leadership of President Dr. Frank Turnage, Germanna aggressively expanded to build the Fredericksburg Area Campus and, with the help of the Culpeper community and Mr. Joe Daniel, the Culpeper Daniel Technology Center. Begun under President Dr. David Sam's careful watch, our expansion in Stafford is a result of the generous support of Stafford County and the Fried Family. And, our plans to construct our new health sciences facility, the Dr. Frank and Nancy Turnage Health Sciences Building, at our Locust Grove Campus, are buoyed by the transformational gift from Mrs. Mary Jane Pitts O'Neill.

We've also expanded virtually as we moved the delivery of all instruction and services online in March due to the pandemic. This was no easy task. Our faculty are leaders in delivering instruction online and moved mountains to ensure a continuity of instruction as we wrapped up our spring term and looked ahead to the summer and fall. Their efforts and expertise, aided by the best Student Services team in the state, were quickly affirmed by a staggering 25% increase in summer enrollment compared to the previous summer as well as an increase in fall enrollment over the previous fall.

The traditional way of delivering instruction to our students is forever changed. We're all-in online, teaching and supporting our students in new ways and reaching more students beyond our traditional service areas. We are committed to active duty service members and their families and working adults who need fast, efficient options for completing their degrees or advancing their careers. We hone our focus on motivated high school graduates and current dual enrolled students, who continue to careers or universities of their choice.

One of Germanna Community College's cultural values is leading-edge innovation to teach and

serve students and communities in groundbreaking ways. For example, we're proud to introduce *College Everywhere*, a 100% online, accelerated degree path for our students to complete their associate degree in just one year, rather than the expected two years. That's fast. This is a unique program within the Virginia Community College System and one which, I truly believe, positions Germanna for creating future success.

But most importantly, when I think about Germanna's future, I think about our transformation and commitment to be an anti-racist institution through Black Minds Matter. The hard work outlined in our Truth and Reconciliation Strategic Plan demonstrates our promise to better attract and serve Black students and other students of color, who have faced years of racial injustice and discrimination. Germanna will be even stronger at advancing the lives of all students, no matter their color, age, background, perspective or ability. It's in our D.N.A. It's what makes us truly us. Our doors are open to all and always open.

Virginia-born educator and author, Booker T. Washington said, "If you want to lift yourself up, lift up someone else." And, "There are two ways of exerting one's strength: one is pushing down, the other is pulling up." No matter our student's goals, many need "lifting up and pulling up" now, more than ever. Many face underemployment or unemployment due to COVID-19. And many continue to face those critical external barriers that keep too many from completing their degrees: Unreliable transportation, housing instability, poverty, hunger, limited access to technology and the internet. COLLEGE EVERYWHERE

Unique to Germanna, this accelerated degree program offers motivated students the option to complete their two-year associate degree in a single year, completely online. *College Everywhere* offers students the opportunity to learn how, when, and where is best for them. Launching in fall 2020, classes are offered in fast 5-week and 7-week sessions. Degrees are offered in Business, College Transfer, Cybersecurity, and Health.

THRIVING ONLINE

We're all-in, online. In late March of this year, as the COVID-19 pandemic spread to every part of the world, faculty and staff transitioned all instruction and services to remote delivery.

Though unprecedented, the College was up to the challenge. Our faculty have long been leaders in delivering instruction online. Their expertise and preparedness in this area were reflected in a staggering 25% year-over-year increase in summer 2020 enrollment.

COMMUNITY FIRST GRANTS

Over the summer, we awarded over \$70,000 of aid to more than 140 students as part of our Community First Grant program. Students use this aid to pursue career training in Automotive, Business, Cybersecurity, Engineering, Education, and Health Sciences.



FREDERICKSBURG NATIONALS PARTNERSHIP

Through a new Educational Partnership Agreement, Naval Surface Warfare Center Dahlgren Division engages with students, faculty and administrators for AEGIS Training and Readiness Center collaboration, professional development opportunities for Germanna faculty, a STEM Student Employment Program as well as support for students transferring to four-year science, technology, engineering, and mathematics degree programs.




His wife Patti Lynch, who's also involved at the ballpark, has spent decades as a teacher and educator in Fredericksburg schools. That's part of her reason for supporting education, including the Germanna Educational Foundation.

Bill Lynch got involved with Sunshine Ballpark and the Cal Ripken Sr. Foundation, not merely because of youth baseball, Patti Lynch says, but because of the usefulness of the ballpark in hosting mentoring and educational events that benefit children in the community. One such event was a visit and talk about the importance of education by Jackie Robinson's daughter Sharon. Others include Badges for Baseball events that feature police officers working with and mentoring kids.

TED AND JACKIE HONTZ

You could say Ted Hontz's interest in education, his focus on disadvantaged students and his concern about diversity developed through a combination of nature and nurture.

Both his parents were physical education teachers. His dad, Bob Hontz, retired as a community college administrator in Central Pennsylvania where Ted grew up.

His family was not well off. He says he didn't get his first haircut in a barber shop until he was in the Navy.

Hontz got into the Naval Academy on an appointment letter signed by the late U.S. Rep. Adam Clayton Powell, a black congressman from Harlem. There were only two African American officers in his class in 1967. He has never forgotten that. One of those black officers went on to become the first black officer to command a nuclear submarine and the other to get a Ph.D. in chemistry and become a college professor. "I got what was essentially an athletic scholarship from a congressman who could not appoint a black because of the continuing segregation and, thus, I took the place of someone who should have had a better shot than I did," he said.

Hontz retired from the Navy as a captain after 28 years and is currently vice president at Basic Commerce and Industries Inc. at Dahlgren. In addition to serving on the Germanna Educational Foundation board, he's on the board of visitors at the University of Mary Washington.

Over time, he said, 'You get smart and figure out what the world is all about." In a sense, Hontz is on a mission to repay Congressman Powell.

My father, who lost his hearing at age 13, was a college professor at Gallaudet [University] and he believed education was the gateway to a full life ~ Jackie Hontz

He loves attending Germanna commencement ceremonies "to see the amazing spectrum of diversity of the students graduating, 18-60 years old, a rainbow of colors and a number the first in their families to graduate from college. Jackie and I believe supporting Germanna's mission greatly helps our community to reach this gateway."






